1. Election of Chairman

5. Apologies for absence

6. Declarations of interest

Councillors were reminded that for those with any interest to be disclosed in relation to an item included in the agenda for this meeting, it was their duty to do so at the appropriate agenda item (as required to be disclosed by Section 96(1) of the LGA 1972, and in accordance with the Parish Councils Order 2001. Councillors had each received a form, which they were required to complete with any declarations of interest on an annual basis.

7. Matters arising from the Minutes of 22 April 2021

- land at 103/105 Long Grove maintenance contractor is willing to maintain ongoing clearance of land, and quotation approved for initial clearance of vegetation, posts and fencing, and provision of new fencing, at a cost of 995.00 + 199.00.
- Small working party to form a planning group for open spaces deferred until cooption of further councillors has taken place.
- Deeds Land Registry had returned a standard response, advising that the situation is being investigated and promising a return of information.
- Wolverton field lease Sir George Brown Trust has not yet managed to obtain a full valuation of the field. Clerk to investigate other routes for obtention of a valuation.
- 59 Long Grove inspection shows the fence posts are already in place on the correct line.
- \$106 monies a response has been received, advising that an exact figure will be available within the next wee.k
- Fallen branch, Withies works have been completed.
- Path adj 14 Wellington Crescent works to be carried out in May.

- Bench Heath End Road suggested that a pipe is laid lengthwise above the ditch, and grassed over, to form a walk way onto land opposite. Other options on placement to be investigated by councillors and brought to the next meeting.
- Tree survey original successful candidate has withdrawn his quotation. The second lowest quotation was then accepted.
- Land rear of 101 Long Grove site cleared, but storage unit left outside fence on parish land, and residents to be notified.
- Domain name and email provision further problems encountered with setting up the domain name and email account, but moving slowly forward.
- Public rights of way campaign HCC are not involved, and Ramblers Association are apparently spearheading campaign. Clerk has written, inviting discussion.
- Council tax charge explanation for the difference in Council tax had been explained by BDBC, but agreed that an overview presentation by them would be useful.
- SLR agreed that first outing of SLR should be Brimpton Road near county boundary. Clerk to purchase padlock, with a ceiling of £20. A new volunteer was identified, but the issue of the lack of a Coordinator still prevents any outings of the SID machine. Cllrs Cockle, Slatford and Terrett initially volunteered to help mount and dismantle the machine.

20. Appendix 1

County, Borough, DAPTC and Police reports

a) <u>County Councillor D Mellor reported:</u>

- an amendment to the last Minutes, when £1bn will be spent on social care
- HCC maintains 2880 miles of rights of way, and has a good rapport with the Ramblers Association, who act as volunteers working on behalf of HCC.
- Provision of a bench on Heath End Road any placing on land owned by HCC would require formal application.
- Speedwatch Police have been active recently on the A340, identifying many speeding drivers. The new Police Commissioner has confirmed that the problem of speeding is part of their proposed activity. A Police check along Baughurst Road will be programmed in the near future.
- Budgets have been trimmed again.
- Resilience Team have carried out various works in Baughurst, notably along Wolverton Road. Replacement of the fencing along Heath End Road is still outstanding.

b) <u>Borough Council reports:</u>

Cllr K Rhatigan reported:

 His pleasure on becoming Councillor for Tadley North, Kingsclere and Baughurst, and how he looked forward to working with the Parish Council. He urged Council to contact him with any queries, and promised to work against large scale developments to help protect the rural wards. He will work on tandem with Borough Councillors Frost and Poland, who are also Ward Members for the same area. Some of his prime areas of interest are promoting job opportunities for youth in the parish, and hidden mental illness.

Cllr G Poland reported:

- He recognised that the previous incumbents, Borough Councillors Bound and Lovegrove, had carried out their roles and served the Parish well, and hoped to replicate their success, looking forward to working with the Parish and its residents.
 <u>Clir S Frost reported:</u>
- He presented apologies for being unable to attend the meeting, but advised that he was proud, happy and thrilled to be elected as Borough Councillor for Tadley North, Kingsclere and Baughurst.
- c) <u>Police report</u>

Police report from PCSO Ireland

A verbal report advised that there had been very little change from the report of the April meeting. Anti social behaviour and arson attacks had lessened, and there were no reports of increased theft in the area.

- e) <u>BDAPTC</u>
 - Of those parish councils who own play areas, 20 out of 50 are combining to use a contractor for quarterly safety inspections, following the decision by BDBC to charge for a service which had previously been free.
